## NOTICE OF COMPLETION FOR THE PROPOSED SIR ADAM BECK #1 GENERATING STATION UPGRADE PROJECT under the Class Environmental Assessment for Waterpower Projects

Ontario Power Generation (OPG) is proposing an upgrade to its Sir Adam Beck #1 Generating Station (GS) by replacing the existing generators on Units 1 and 2 with two new up-to-date generators (the Project).

The Sir Adam Beck #1 GS is located at 14000 Niagara Parkway, Niagara on the Lake. It takes water from the Welland River and the Niagara River through an open-cut channel and discharges into the Niagara River (see map).

This Project is subject to the Class Environmental Assessment for Waterpower Projects (Class EA) and is categorized as a *Project Associated with Existing Infrastructure on a Managed Waterway* pursuant to the Class EA. An Environmental Report (ER) has been prepared as required under the Class EA. The proposed Project has been reviewed in a process consistent with the Class EA for Waterpower Projects, the results of which are described in the Sir Adam Beck #1 GS Generator Upgrade Project ER. The ER's conclusions indicate the Project would have no negative effect on atmospheric, terrestrial, heritage and socio-economic environments.


In compliance with the Class EA, the ER will be available for review and comment for a 30-day review period from Dec. 28, 2017 to Jan. 26, 2018. During this review period, hard copies of the ER will be available at OPG's Sir Adam Beck GS.

In the event that issues cannot be resolved during the review period, the concerned party may make a written request to the Minister of the Environment and Climate Change at the address below for a Part II Order under the Environmental Assessment Act (Individual Environmental Assessment). A copy of the Part II Order request must also be sent to OPG at one of the addresses above.
